FORM LLC-1 ATTACHMENT
SALAAM YOUTH AND COMMUNITY CENTER, LLC

ONE: This LLC is not organized for the private gain of any person. The specific and primary purpose for which this LLC is organized is to provide refugees with a convenient, central location in San Diego, California to access coordinated services and resources.

TWO:

- (a) This LLC is organized and operated exclusively for charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) The LLC is operated exclusively to further the charitable purpose of its Members.
- (c) The LLC may not carry on activities not permitted to be carried on by an organization described in Section 501(c)(3).
- (d) No substantial part of the activities of this LLC shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the LLC shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

THREE:

- (a) At all times the Members of the LLC must be 501(c)(3) organizations or governmental units or wholly owned instrumentalities of a state or political subdivision thereof ("Governmental Units or Instrumentalities").
- (b) The LLC or its Members are prohibited from any direct or indirect transfer of membership interest in the LLC to a transferee other than a section 501(c)(3) organization or Governmental Unit or Instrumentality.
- (c) The LLC, interests in the LLC (other than membership interest), or its assets, may only be availed of or transferred to (whether directly or indirectly) any nonmember other than a Section 501(c)(3) organization or a Governmental Unit or Instrumentality in exchange for fair market value.
- (d) The LLC shall not distribute any assets to members who cease to be organizations described in section 501(c)(3) or Governmental Unit or Instrumentalities.

FOUR:

- (a) The property of this LLC is irrevocably dedicated to charitable, educational and scientific purposes within the meaning of Revenue and Taxation Code Section 23701(d) and no part of the net income or assets of this organization shall ever inure to the benefit of any manager, officer or private person.
- (b) On the dissolution or winding up of the LLC, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this LLC, shall be distributed to the LLC's members in amounts equal to their membership interests, provided that the members are organized and operated exclusively for educational, charitable and/or scientific purposes and continue to be recognized as tax-exempt under Section 501(c)(3) of the Internal Revenue Code.

FIVE: Any amendments to these Articles of Organization or to the Operating Agreement of the LLC must be consistent with section 501(c)(3) and be approved by the requisite vote of the Members.

SIX: To the fullest extent permitted by law, for the purpose of qualifying for the Welfare Exemption under the rules of the California Board of Equalization, this limited liability company is prohibited from merging or converting into a for-profit entity.

SEVEN: In the event that one or more members of the LLC cease at any time to be an organization described in section 501(c)(3) or a Governmental Unit or Instrumentality, the membership interest of that member shall be forfeited to the remaining exempt members, or alternatively a forced sale shall be effectuated to another eligible 501(c)(3) organization approved by the remaining exempt-members, within ninety (90) days unless retroactive reinstatement is obtained.
