Corporate Bylaws of Pinpoint Land Surveying

Article I: Name and Location

1. The name of the Corporation shall be Pin Point Land Surveying.
2. The principal office of the Corporation shall be located at 670 9th Street, Suite 201, Arcata, California.

Article II: Purpose

1. The purpose of this Corporation is to engage in the business of land surveying, Land development and Land Planning and any other lawful activities permitted under the laws of the State of California.

Article III: Shareholder

1. The Corporation shall have one shareholder, Loren J. Blodgett, who holds one share of common stock in the Corporation.

Article IV: Board of Directors

1. The Corporation shall not be required to have a Board of Directors due to the singular nature of its ownership. The sole shareholder shall have full authority to make decisions regarding the management and affairs of the Corporation.

Article V: Meetings

1. **Annual Meetings:** An annual meeting of the shareholder shall not be required due to the single-shareholder structure. However, the shareholder may hold meetings as necessary.
2. **Special Meetings:** Special meetings of the shareholder may be called by the shareholder or as otherwise provided in these bylaws.

Article VI: Voting

1. The shareholder shall have one vote, which may be cast in person or by written consent for any matter requiring approval.

Article VII: Officers

1. The Corporation shall have at least the following officers:
 - **President:** Loren J. Blodgett
 - **Secretary:** Loren J. Blodgett
 - Additional officers may be appointed as necessary.

Article VIII: Indemnification

1. The Corporation shall indemnify to the fullest extent permitted by law any person who serves or has served as an officer or agent of the Corporation, against expenses and liabilities incurred in connection with the Corporation.

Article IX: Amendments

1. These bylaws may be amended or repealed by the shareholder at any time by a written instrument signed by the shareholder.

Article X: Records

1. The Corporation shall maintain complete and accurate books and records of the Corporation's business and affairs, including minutes of all meetings.

Article XI: Fiscal Year

1. The fiscal year of the Corporation shall end on the 31st day of December each year.

Article XII: Miscellaneous

1. Any provision of these bylaws that is inconsistent with California law shall be deemed amended to comply with the law.
