The undersigned, ALLAN HANCOCK and EMIL A. OLSON, do, and each of them does, hereby certify as follows:

One: Said Allan Hancock is now and at all times subsequent to a date prior to October 16, 1945, has been the President of the University of Southern California, a benevolent, charitable and nonprofit corporation, organized under the laws of the State of California on November 15, 1895.

Two: Said Emil A. Olson is now and at all times subsequent to a date prior to October 16, 1945, has been the Secretary of said University of Southern California.

Three: At all times since the organization of said University of Southern California, and at all times since November 15, 1945, up to the time of the execution of this certificate, University of Southern California has carried on and continued its business and other activities and has continuously acted as a corporation and done business as such.

Four: On the 16th day of April, 1946, there was filed with said Emil A. Olson as said Secretary of University of Southern California, a written approval and adoption of amendment to the Articles of Incorporation of University of Southern California as heretofore amended in form set forth in indented words and figures as follows, to-wit:

Six: The entire voting power of said University of Southern California is, by virtue of its Articles of Incorporation as heretofore amended, vested in a membership of thirty persons. There are four vacancies in said membership, due to deaths.

Seven: The total number of members of University of Southern California entitled to vote on or consent to the adoption

of the aforesaid amendment is twenty-six.

Eight: The number of the members of said University of Southern California consenting to said amendment is seventeen. Said seventeen members so consenting hold at least a majority of the voting power.
