#### **Duration**

## **Personal Liability**

To the fullest extent permitted under California Law no officer or director of this corporation shall be personally liable for the debts or obligations of this corporation, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

#### **Prohibited Activities**

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **BOARD OF DIRECTORS**

#### Governance

This corporation shall be governed by its board of directors.

#### **MEMBERSHIP**

### Membership

This corporation shall have no members. The management of the affairs of the corporation shall be vested in a board of directors, as defined in the corporation's bylaws.

## **AMENDMENTS**

Any amendment to the Articles of Incorporation may be adopted by approval of two-thirds (2/3) of the board of directors.
