**PURPOSE AND MISSION STATEMENT  
GOP UNION CUACUS**

**Additional Statements, first paragraph – specific purpose, continued:**

- 1) To operate exclusively for the charitable, social welfare of the public through advocacy, educational, & civic engagement within the meaning of section 501(C) (4) of the Internal Revenue Code.
- 2) Protect the American worker from intimidation and bullying that targets him/her due to the exercising his or her God-given constitutional/legal rights.
- 3) The betterment of the working conditions of all Americans through the development of higher degrees of work related efficiency in their respective occupations.
- 4) To advocate for higher productivity, lower employee turnover, improved workplace communication, and a better-trained workforce with access to additional professional training and productive union and professional meetings.
- 5) To acknowledge our support for Republican candidates that support our values by giving financial, volunteer, and promotional support.
- 6) Defend the rights of all American workers to defend their constitutional rights both in and outside of the work arena.
- 7) Partner with individuals, and diverse organizations to create/promote, and/or improve strategies for community economic and leadership growth through diverse activities and programs.
- 8) Utilizing objectives and activities which contribute to the educational, civic, financial, and social betterment of diverse economic communities and promote the uplifting of the public's social welfare.
- 9) Educate the public on advocacy strategies which can be used during disputes with work managers.
- 10) Processes complaints from member partners concerning services provided by unions, and/or work entities, or it's representative (an organization's managerial member qualifies as an entity's representative); meet with the parties involved to encourage resolution of the problem; recommend fair solutions, and if the proposed solution is not accepted, inform the parties about appropriate judicial or administrative bodies that may be used to resolve the dispute(s).
- 11) Encourage governmental leadership support of our mission through Political Action Committees; and civil/community/government partners.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code.
