This Agreement of Merger (this "Agreement") is entered into as of March 2, 200 between ARI Service, Inc., a California corporation ("ARI"), and AST Research, Inc., a Delaware corporation ("AST").

- 1. AST shall be merged with and into ARI, with ARI surviving.
- 2. Automatically, and by virtue of the merger:
- (a) Each share of AST stock held in the treasury of AST immediately prior to the merger shall be cancelled and retired and cease to exist without any conversion thereof.
- (b) Each AST share issued and outstanding immediately prior to the merger shall be converted into and evidence one share of ARI.
- (c) Each ARI share issued and outstanding immediately prior to the merger shall be canceled and retired and resume the status of authorized and unissued shares of ARI stock.
- 3. The Articles of Incorporation of ARI shall be amended to restate Article IV in its entirety to read as follows: "This corporation is authorized to issue only one class of shares of stock, and the total number of shares which this corporation is authorized to issue is fifteen million (15,000,000)" and shall, as so amended, be the Articles of Incorporation of the surviving corporation.
- 4. AST shall from time to time, as and when requested by ARI, execute and deliver all such documents and instruments and take all such action necessary or desirable to evidence or carry out this merger.
- 5. The effect of the merger and the effective date of the merger are as prescribed by law.
