ARTICLES OF INCORPORATION OF JENNIFER RAE FOLEY, M.D. CONSULTING

I

The name of this corporation is JENNIFER RAE FOLEY, M.D. CONSULTING

II

III

This corporation is a professional corporation within the meaning of Title 1, Division 3, Part 4 of the California Corporations Code. The purpose of the corporation is to engage in the profession of radiology and any other lawful activities (other than the banking or trust company business) not prohibited to a corporation engaging in such profession by applicable laws and regulations.

IV

This corporation's initial agent for service of process is Steven H. Wilhelm, Attorney at Law, 1950 Fifth Avenue, Suite 100, San Diego, CA 92101.

This corporation is authorized to issue only one class of shares, which shall be designated as "common" shares. The total number of such shares authorized to be issued is 1,000,000 (One Million).

VI

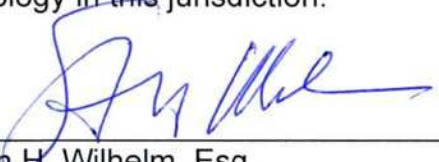
