- b) When distributing remaining assets upon dissolution as per paragraph five of the 'additional statements' above, (a) Priority consideration shall be given to funds, foundations or corporations whose purposes are similar to the specific purpose provision in this document; and (b) Only funds, foundations or corporations also meeting the requirements of taxation and revenue code section 214 shall be considered and eligible to receive such distributions.
