Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for <b>charitable</b> , <b>educational and/or religious</b> purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).

## Articles of Incorporation of Pentecostal Church of God, I.M., 209RPCA

The general purposes and powers of this corporation are to have and exercise all rights and powers conferred on Nonprofit Religious Corporations under the laws of the State of California.

No real property shall be bought or sold by the corporation without the consent of its President and the Board of Directors, and without obtaining written approval from the President of the Board of Directors or another member of the Board of Directors of Pentecostal Church of God, I.M., Pacific Region.

The general management of the affairs of this corporation shall be under the control, supervision, and direction of the Board of Directors. The Authorized number and qualifications of the Directors shall be set forth in the bylaws of the corporation.

These articles of incorporation may not be amended without the written consent of Pentecostal Church of God, I.M., Pacific Region.
