**I.
NAME**

The name of the corporation is: San Francisco's 2025 Inaugural Fund (the "Corporation").

**II.
PURPOSE**

A. This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public purposes.

B. The specific purposes of this Corporation are to:

1. Promote the social welfare of the City of San Francisco through providing assistance in and funding to activities related to the 2025 Inauguration of the Mayor of the City of San Francisco and the transition associated with assuming the office of Mayor of the City of San Francisco by promoting local civic engagement and the City of San Francisco and to lessen the burdens of government related to these activities and expenses that would otherwise be supported by the city's budget; and

2. Engage in any and all other public activities incidental or reasonably necessary to effect the specific purposes enumerated in Article II(B)(1) of these Articles, which are permitted to an organization that promotes social welfare and is exempt from federal income tax under section 501(c)(4) of the Internal Revenue Code, as amended, and California income tax under section 23701f of the California Revenue and Taxation Code, as

amended. To these ends, the Corporation may do and engage in any and all lawful activities, and it shall have and exercise all other powers and authority now or hereinafter conferred upon nonprofit public benefit corporations in the State of California.

LIMITATION OF CORPORATE ACTIVITY


A. The Corporation is organized and operated exclusively for social welfare purposes and shall not carry on any activities not permitted by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code, as amended, and section 23701f of the California Revenue and Taxation Code, as amended.

VI.
DISPOSITION

A. The property of the Corporation is irrevocably dedicated to social welfare purposes and no part of the net income or assets of this Corporation shall ever inure to the benefit of any director, officer, or member of the Corporation or to the benefit of any private person.


B. Upon the dissolution or the winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation shall be distributed to one or more nonprofit funds, foundations, or corporations which are organized and operated exclusively for charitable and/or social welfare purposes and which have established tax exempt status under sections 501(c)(3) or 501(c)(4) of the Internal Revenue Code, as amended, and Sections 23701d or 23701f of the California Revenue and Taxation Code, as amended.
