ADDITIONAL STATEMENTS – ARTICLES OF INCORPORATION FOR GRAND GARDEN HOMEOWNERS ASSOCIATION

No part of the net earnings of this corporation shall inure to the benefit of any private member or individual other than by acquiring, constructing, or providing management, maintenance, and care of association property and other than by a rebate of excess membership dues, fees, or assessments.

These articles may be amended by the affirmative vote or written assent of a majority of the Board and by the members representing (1) a majority of the entire voting power of the Association, and (2) a majority of the voting power of the Association residing in members other than the Declarant, SLR INVESTMENTS, LLC, a California Limited Liability Company, its/their successors and assigns.
