WHEREAS, the Shivwits Band of Paiutes is a federally recognized Indian Tribe as defined under the Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, and operates in accordance with terms and conditions of the Paiute Indian Tribe of Utah Constitution approved July 15, 1991 and the Shivwits Band Bylaws as amended, and other duly adopted and approved Tribal and Band laws, ordinances, codes and guidelines; and,

WHEREAS, pursuant to Article VIII, Section 3 of the Shivwits Band Bylaws, I am vested with the authority and responsibility to perform all duties of a secretary; and,

WHEREAS, the Shivwits Band Council enacted the Shivwits Limited Liability Code by Shivwits Band Resolution 2020-02 on March 11, 2020 (Shivwits LLC Code); and,


WHEREAS, the Shivwits Band Corporation caused a Certificate of Organization to be filed under the Shivwits LLC Code for the formation of Kaiva Services, LLC on March 11, 2020; and,

WHEREAS, the Office of the Secretary accepted the Certificate of Organization for filing thereafter on March 11, 2020; and,

WHEREAS, I have knowledge of the limited liability company's status within this jurisdiction;
