**ADDITIONAL STATEMENTS CONTINUED**

- A. The Corporation will not have members. The Corporation shall have a Board of Directors as the governing body of the Corporation, consisting of no less than three and no more than twelve members. Directors of the Corporation shall be known as trustees, and the governing body of the Corporation shall be the Board of Trustees.
- B. The Bishop of the Coptic Orthodox Church – Diocese of Los Angeles, Southern California and Hawaii, or his successors in office, shall, by virtue of his office, be a trustee of this corporation. The members of the board of trustees shall be appointed by the Bishop of the Coptic Orthodox Church - Diocese of Los Angeles, Southern California and Hawaii and shall serve at the pleasure of the Bishop of the Coptic Orthodox Church - Diocese of Los Angeles, Southern California and Hawaii.
- C. The Board may delegate the management of the activities of the Corporation to any person or persons provided that the activities and affairs of the Corporation shall be managed and all corporate powers shall be exercised under the ultimate direction of the Board.
