**ARTICLES OF INCORPORATION OF  
BERYLWOOD VILLAGE HOMEOWNERS ASSOCIATION**

**ARTICLE I**

The name of the corporation is **BERYLWOOD VILLAGE HOMEOWNERS ASSOCIATION**.

An existing unincorporated association, **BERYLWOOD VILLAGE HOMEOWNERS ASSOCIATION**, is being incorporated by the filing of these Articles.

**ARTICLE II**

**PURPOSE OF CORPORATION**

This corporation is a **Nonprofit Mutual Benefit Corporation** organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity, other than credit union business, for which a corporation may be organized under such law.

This corporation is an "association" formed to manage a common interest development under the Davis-Stirling Common Interest Development Act (Civil Code Sections 4000, et seq.) This corporation is formed for the following specific and primary purposes:

(A) To manage, maintain and preserve the residential condominium project located within that certain real property described as Parcels B and C of Parcel Map 79-2, City of Oxnard, County of Ventura, State of California, as per Map recorded in Book 28, Page 20, of Parcel Maps in the office of the Recorder of Ventura County.

(B) To promote the health, safety and welfare of the residents of the project.

(C) To exercise the powers granted to a non-profit mutual benefit corporation enumerated in Corporation Code Section 7140.

(D) To operate a homeowners association within the meaning of Section 23701(t) of the California Revenue and Taxation Code.

**ARTICLE III**

However, the percentage of voting power necessary to amend a specific clause or provision shall not be less than the prescribed percentage of affirmative votes required for action to be taken under that clause.
