Articles of Incorporation

A California Nonprofit Public Benefit Corporation

- 1. The name of this corporation is LA Alliance for Human Rights.
- 2. The name of the existing unincorporated association now being incorporated by the filing of these Articles of Incorporation pursuant to California Corporations Code Section 5121 is the LA Alliance for Human Rights.
- 3. This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of and person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.
- 4. The specific public and charitable purposes of the Corporation include but are not limited to the pursuit of solutions, including litigation, for the human rights crisis in of homelessness in Los Angeles, including but not limited to that caused by mental illness.
- 5. The name and California address of the Corporation's initial agent for service of process is Elizabeth Mitchell, 617 W. 7th Street, Suite 200, Los Angeles, CA 90017-3868.
- 6. The Corporation is organized and operated exclusively for the purposes set forth in Article 3 within the meaning of Section 501(c)(3) of the Internal Revenue Code. The Corporation is not organized for profit or organized to engage in an activity ordinarily carried on for profit. No part of the net earnings of the Corporation will benefit any private member or individual.
- 7. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

- 8. The property of this corporation is irrevocably dedicated to the purposes in Article 3 hereof and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- 9. Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).
- 10. Notwithstanding any of the above statements of purposes and powers, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purposes of this Corporation.
