## Nguyen Funnyfarm

*(A California Nonprofit Public Benefit Corporation)*

### 1. Purpose Statement

The specific purpose of this corporation is **to reduce food waste by repurposing unused produce for livestock feed, promote sustainable farming practices, and support local food security initiatives**. The corporation is organized and operated exclusively for charitable, educational, and scientific purposes within the meaning of **Section 501(c)(3) of the Internal Revenue Code**.

### 2. Dedication of Assets

All assets of this corporation are **irrevocably dedicated** to charitable, educational, or scientific purposes. Upon dissolution, after settling all liabilities, any remaining assets shall be distributed to an organization that qualifies as a tax-exempt nonprofit under **Section 501(c)(3) of the Internal Revenue Code**.

### 3. Private Benefit Limitation

No part of the net earnings of this corporation shall **inure to the benefit of, or be distributable to**, any private individual, except as reasonable compensation for services rendered in furtherance of the corporation's tax-exempt purposes.

### 4. Political Activities Restriction

No substantial part of the corporation's activities shall involve carrying on propaganda or attempting to influence legislation. The corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office.
