<u>SECOND</u>: The principal office for the transaction of the business of this Corporation Sole is located at 7451 Auburn Blvd, Suite C, #997, Citrus Heights, Sacramento County, California. All mail should be addressed care of: Allison Elias, Sovereign Minister.

THIRD: To the fullest extent permitted by law, this corporation shall be governed and shall operate at all times, in accordance with the Canon Law of Pay It Forward Ministries. Such canons, statutes, decrees, policies, guidelines, directives, and orders are purely ecclesiastical in nature and, as such, are matters of internal church governance. The interpretation and application of such canons, statutes, decrees, policies, guidelines, directives, and orders shall be made by Pay It Forward Ministries to their own internal policies and canonical procedures. To the fullest extent permitted by law, such canons, statutes, decrees, policies, guidelines, directives, and orders of the Church are not, and shall not be subject to judicial review by a civil court or any civil authority. The affairs of the Corporation Sole shall be regulated by Rodney Cole, Vicar, operating at 7451 Auburn Blvd, Suite C, #997, Citrus Heights, CA 95610. The Vicar shall designate his successor who shall become Vicar upon the death of the present Vicar. In the event that the Vicar fails to designate his successor, any vacancy in the position of the Vicar shall be filled by Shelby Lynn Curl.

<u>FOURTH</u>: The undersigned Vicar is vested with the authority to form this corporation in accordance with the rules and disciplines of Pay It Forward Ministries.

<u>FIFTH:</u> The property of this corporation is irrevocably dedicated to religious and charitable purposes and no part of the net income of assets of this organization shall ever insure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets, remaining after payment or provisions for payment of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious and charitable purposes and which has established its tax-exempt status under Section 501 (c)(3) or 508 (c)(1) of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Code. This corporation will not as a substantial part of its activities attempt to influence legislation or participate to any extent in a political campaign for or against

any candidate for public office. This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the religious and charitable purposes of this corporation.
