# Attachment to the Articles of Incorporation of

### **VETERAN CONTRACTOR, INC**

## **Limitation of Directors Liability**

The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under the California Law.

### **Indemnification of Agents**

The corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) for breach of duty to the corporation and shareholders through bylaw provisions or through agreements with the agents or both, in excess of indemnification otherwise permitted by Section 317 of the California Corporations Code, subject to the limits on such excess indemnification set forth in Section 204 of the California Corporations Code.

### Repeal or Modification of the Limitation of Directors Liability and Agent Indemnification

Any repeal or modification of the foregoing provisions of Directors Liability Limitation and Agent Indemnification by the shareholders of this corporation shall not adversely affect any right or protection of an agent of this corporation existing at the time of such repeal or modification.
