ATTACHMENT TO ARTICLES OF INCORPORATION

Highland Maintenance Association

Additional Statements – Continued:

The nonprofit purposes of this corporation are governed, in part by California Revenue & Taxation Code Section 23701(t) and applicable provisions of the United States Internal Revenue Code, Section 528, as may be amended from time to time. No part of the net earnings of the corporation shall inure (other than by providing management, maintenance and care of the real property or by a rebate of excess membership dues, fees and assessments) to the benefit of any private Member or individual.

These Articles may be amended only by the affirmative vote of a majority of the Board of Directors, and by the affirmative vote of Members representing a majority of the voting power of the corporation and a majority of the votes of Members other than Declarant, or where the two (2) class voting structure is still in effect (as provided in the Bylaws), a majority of each class of membership. Any vote on a proposed amendment to these Articles shall be held by secret written ballot in accordance with the procedures set forth in California Civil Code Section 5100, *et seq.*, as may be amended or superseded, and the rules and regulations adopted by the Board of Directors of the corporation.
