**Articles of Incorporation of a Nonprofit Public Benefit**

The undersigned incorporator, for the purpose of forming a nonprofit corporation under the laws of the State of California, hereby certifies:

**ARTICLE ONE  
CORPORATE NAME**

The name of this corporation is C.G. JUNG INSTITUTE OF SAN DIEGO

**ARTICLE TWO  
CORPORATE PURPOSE**

a. This corporation is a nonprofit PUBLIC BENEFIT CORPORATION and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public purposes.

b. The specific purposes of this corporation are to train individuals to become certified Jungian Analysts through operation of an institution for this purpose, and through seminars and workshops; to educate members of the public in the writings and teachings of C.G. Jung and Depth Psychology/Analytical Psychology through seminars, workshops, lectures and publications; to provide continuing education for therapists who know and follow the writings and teachings of C.G. Jung, and provide a forum for analyst members to collectively advance their understanding and knowledge of these teachings. The corporation may take such other steps as will facilitate these purposes, and may engage in any other lawful activities permitted under the California Nonprofit Public Benefit Corporation Law.

ARTICLE FIVE  
ADDITIONAL STATEMENTS

a. This corporation is organized and operated exclusively for the purposes set forth within the meaning of Internal Revenue Code section 501(c)(3).

b. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

c. The property of this corporation is irrevocably dedicated to the purposes set forth herein and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

d. Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).

e. Notwithstanding any of the above statements of purpose and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purpose of this corporation.
