Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable , educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).

Attachment -- Full Specific Purposes

1. Receive charitable donations from community at large and use it for the religious, educational and charitable purposes of the Corporation.

2. Establish, build, and operate a temple, a permanent place of worship and a traditional style Hindu temple complex including a community hall for the devotees which will serve as a cultural center with a small library (containing religious books and literature, books on theology, Hindu scriptures etc), and hold regular Bhajans, and classes in religion and performing arts.

3. Provide priestly and all related services like Shodasa Samskaaraas/Karmaas, i.e., 16 kinds of Hindu rituals needed for Janma Prabhruti & Aavasaana paryantam throughout a person's life-cycle).

4. Celebrate and perform all religious festivals and rituals - on the basis and principles of Hinduism and the ancient Vedic and Aagama Saastras.

5. Impart knowledge of Vedic principles, rituals, culture, values and tradition to the community; and impart Vedic Education and help practice the ancient Vedic System of life to those who are interested on the basis and principles of Hinduism.

6. Arrange, facilitate and support learning of art, music, traditional dance, languages, culture, healthy pastime and other needs of good living.

7. Interact with other organizations and individuals of other religious faiths to promote mutual understanding, respect, and tolerance; and facilitate and create opportunities for cultural exchanges amongst various populations in the United States of America.

8. Such other purpose(s) as the Board of Directors may determine.
