ATTACHMENT TO ARTICLES OF ORGANIZATION OF BROKEN HORN, LLC

INDEMNIFICATION OF AGENTS

Section 1: The liability of the agents of this Limited Liability Company for monetary damages shall be eliminated to the fullest extent permissible under California law.

Section 2: The Limited Liability Company is authorized to provide indemnification of agents (as defined in Section 17704.08(d)(2)(A) of the California Corporations Code) in accordance with the terms and conditions of its Operating Agreement, agreements with agents, or both, in excess of the indemnification otherwise permitted by Section 17704.08 of the California Corporations Code, subject only to the limits set forth in Section 17701.10(g) of the California Corporations Code with respect to: (i) a breach of the duty of loyalty; (ii) a financial benefit received by the member or manager to which the member or manager is not entitled; (iii) a member's liability for excess distributions under Section 17704.06 of the California Corporations Code; (iv) intentional infliction of harm on the Limited Liability Company or a member; or (v) an intentional violation of criminal law. The Limited Liability Company is further authorized to provide insurance for agents as set forth in 17704.08(c) of the California Corporations Code.

Section 3: Any repeal or modification of the foregoing provisions of Sections 1 and 2 hereof by the members of this Limited Liability Company shall not adversely affect any right or protection of an agent of this Limited Liability Company existing at the time of such repeal or modification."
