## Attachment to Articles of Incorporation

**Entity Name:** Coal Creations, Inc.

### **Section:** Share Structure

Coal Creations, Inc., hereby incorporates the following descriptions of its share classes as part of its Articles of Incorporation:

#### **1. Class A Shares: Ownership and Dividend Shares**

- **Total Issued:** 99,000 shares
- **Description:** Class A shares are designated primarily as ownership and dividend shares. Holders of Class A shares are entitled to receive dividends as declared by the board of directors. These shares represent the equity ownership of the corporation and entitle the shareholders to a proportional share of the corporation's assets and profits in terms of dividends and distributions upon dissolution. Class A shares have no voting rights except as provided by law. (*See, e.g.,* Corporations Code § 903.)

#### **2. Class B Shares: Voting Rights**

- **Total Issued:** 1,000 shares
- **Description:** Class B shares are designated primarily as voting shares. Holders of Class B shares have full voting rights and are responsible for the election of directors, approval of new shareholders, and making decisions on significant corporate actions. These actions include, but are not limited to, mergers, acquisitions, corporate finance decisions, major asset purchases, and changes to corporate bylaws or articles. Class B shares have equal ownership and rights to dividends as Class A shares but are distinct in their enhanced voting power and influence over corporate governance.

Notwithstanding the difference in their voting privileges, both Class A and Class B shares are “common shares” within the meaning of Corporations Code § 159 insofar that every share – whether the share be a Class A share or a Class B share – has an equal claim with respect to the distribution of assets on liquidation or with respect to the payment of dividends.

Both Class A and Class B shares are integral to the governance structure and financial strategy of Coal Creations, Inc., reflecting a balanced approach to management authority and financial participation.
