PURPOSE AND MISSION STATEMENT THE CANNABIS CHAMBER OF COMMERCE, International ("The Corporation")

Additional Statements, first paragraph – specific purpose, continued:

- 1) The primary purposes & activities of the corporation can be described as follows:
 - a. To serve the members and the community exclusively for educational, charitable, research & development for the purposes of improving business & community conditions within the meaning of Section 501(c)(6) of the Internal Revenue Code.
 - b. To serve as a nonprofit organization dedicated to fostering a supportive ecosystem for businesses operating within the cannabis industry.
 - c. To enhance the operational, financial, and regulatory environment for cannabis-related enterprises, ensuring they thrive in a competitive market. In doing so, growing the same areas within the surrounding communities.
 - d. To offer a range of services; including assisting in safety regulatory practices, advocacy, education, networking opportunities, access to resources, community rehabilitation, and addressing the unique challenges faced by cannabis businesses.
 - e. To be committed to supporting patient and member services, ensuring that individuals who rely on cannabis for medicinal purposes have access to high-quality, safe, and effective products.
 - f. To seek to promote industry standards, encourage ethical business practices, and contribute to the overall development, safety regulatory research and development, and legitimacy of the cannabis sector.
 - g. The Corporation is designed as a forward-thinking organization that champions a holistic and patient-centered approach to wellness and community development.
 - h. To advocate for the responsible use of cannabis as a nonpharmacological alternative for pain management and a potential aid in reducing dependency on more harmful substances.
 - i. By leveraging cannabis's therapeutic properties, The Corporation aims to support individuals in their journey towards recovery and improved mental health, emphasizing compassionate care and personalized treatment plans.
 - j. To advocate and foster community development and partnerships through common sense, economically sustainable strategies that enhance the overall wellness of both individuals and businesses within the community.
 - k. To promote educational initiatives, support cannabis research (to include research of the benefits and effects of cannabis), and advocate for policies that recognize the role of cannabis in holistic health practices.
 - 1. To promote, and engage in community and government collaboration efforts.
