The name of this corporation is **Amend Lives Housing Resources Foundation, Inc**

**II. PURPOSES**

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

The public and charitable purpose of this corporation are to operate a nonprofit organization in a positive and safe environment, offering supportive services and various activities to those within our community and beyond, that includes women, teens, youth, elderly, families, men, low-income/disable, young adults, children, and Veterans, these services, programs, activities. Uplifting and building lives in providing housing services in the fight against homelessness, through transitional housing, permanent housing, supportive housing services, first time home-buyers programs and services, including entrepreneurship, business models, mentoring, self-esteem/empowerment, case management, outreach services, case management activities, community development, and networking. Amend Lives Housing Resources Foundation, Inc will also provide services and resources that will include programs/services/referrals, life skills, financial literacy workshops, credit repair building, mentoring services, programs for youth, and services toward empowerment building, that will lead to productive life style, in the process of addressing the health and wellness to members of our community and beyond, spiritually, mentally and physically, seeking to bring about life positive changes. We will do this in collaboration with community service providers, national, international, global and partnership through grants, fundraising activities and through outreach activities, community and corporate sponsorship.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501 ©(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law), or by corporation contributions which deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provisions of any future United States Internal Revenue Law).

**III. INITIAL AGENT FOR SERVICES OF PROCESS**

**V.** This corporation is organized and operated exclusively for **charitable** purpose within the meaning of Internal Revenue Code section 501(c) (3).

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

**VI.** The property of this corporation is irrevocably dedicated to **charitable** purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for **charitable** purposes and which has established its tax exempt status under Internal Revenue Code section 501(c) (3).
