## ATTACHMENT TO ARTICLES OF INCORPORATION OF LAYMAN RESIDENTIAL SOLUTIONS, INC.

## 7. Hold Harmless; Indemnification.

- a. The liability of directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law. The corporation is authorized to indemnify the directors and officers of the corporation to the fullest extent permissible under California law.
- b. The corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) for breach of duty to the corporation and its stockholders through Bylaw provisions, agreements with agents, vote of shareholders or disinterested directors, or otherwise to the fullest extent permissible under California law, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject to the limits on such excess indemnification set forth in Section 204 of the California Corporations Code.
- c. Any amendment, repeal, or modification of any provision of this Article shall not adversely affect any right or protection of an agent of this corporation existing at the time of such amendment, repeal, or modification.
