Articles of Incorporation

I. NAME

The name of this corporation is **Hatcher Housing Resources Foundation, Inc**

II. PURPOSES

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

The public and charitable purpose of this corporation are to operate a nonprofit organization in a positive and safe environment, offering supportive services and various activities to men, youth, women, teens, children, families, young adults, including Veterans. These services will include housing support, mentorship, entrepreneurship, case management services, outreach activities, support groups, employment services, transitional and stable housing services, supported transportation services, apprenticeship programs, and crisis intervention. These services will also be offered to at-risk teens, parolees, individuals coming from incarceration, individuals that are incarcerated, displaced individuals, families, youth coming out of foster care, focusing on the mental and physical health of our community, including self-esteem building empowerment, community networking, interactive health and wellness workshops, community building, taking our community and its members from at risk, to success. We will do this in collaboration with community service providers and partnership through grants, fundraising activities and through outreach activities, community and corporate sponsorship.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501 ©(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law), or by corporation contributions which deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provisions of any future United States Internal Revenue Law).


IV. CORPORATE ADDRESS

The property of this corporation is irrevocably dedicated to **charitable** purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for **charitable** purposes and which has established its tax exempt status under Internal Revenue Code section 501(c) (3).
