ADDITIONAL TERMS TO FORM LLC-1 FOR CAMPUS OF LIFE II, LLC

7. Charitable Purpose. The Company is organized and shall be operated exclusively for charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including without limitation, the specific purpose of providing educational services to the community.

The Company shall have all powers now or hereafter granted by law, and in addition, shall have all powers lawfully necessary or required to carry out its purposes and objects. All of the assets or earnings of the Company shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. No part of the Company's net earnings shall inure to the benefit of any individual, and no part of the Company's activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

8. <u>Dissolution</u>. Upon a dissolution of the Company, the residual assets of the Company will be turned over to Friends of Chabad Lubavich, San Diego ("Chabad"), so long as Chabad is an organization described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, and, if not, then to one or more organizations which are described in Sections 501(c)(3) and 170 (c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose.
