Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for <b>charitable, educational and/or religious</b> purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).
