#### ATTACHMENT TO ARTICLES OF INCORPORATION

## THE JOURNEY FORWARD, LICENSED MARRIAGE AND FAMILY THERAPY, INC.

#### **ELIMINATION OF DIRECTOR LIABILITY**

The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

#### **INDEMNIFICATION**

The corporation is authorized to indemnify the directors and officers of the corporation to the fullest extent permissible under California law.

### **QUALIFICATION OF SHAREHOLDERS**

This corporation is subject to the restrictions on the qualifications of shareholders imposed by Title 1, Division 3, Part 4, of the California Corporations Code and other applicable laws, rules, and regulations which provide that only the following may be shareholders of a licensed marriage and family therapy corporation:

- A. Holders of a valid marriage and family therapist license issued by the division of licensing of the California Board of Behavioral Sciences;
- B. Licensed persons as defined in Section 13401.5(g) of the California Corporations Code, provided that (1) the number of shares in the corporation owned by such persons does not exceed forty-nine percent (49%) of the total shares issued by the corporation and (2) the number of such persons owning shares in the corporation does not exceed the number of licensed clinical social workers owning shares in the corporation.
