

ATTACHMENT TO ARTICLES OF INCORPORATION OF A NONPROFIT PUBLIC BENEFIT CORPORATION (ARTS-PB-501(c)(3)

4. Purpose Statement

b. The specific purpose of this corporation is to provide financial support to individuals and families that are in need as a result of a disaster, war, death in the family, or other crisis, and by supporting organizations that assist people in need, both domestically and internationally.

5. Additional Statements

- e. The corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- f. The corporation won't engage in any act of self-dealing, as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- g. The corporation won't retain any excess business holdings, as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- h. The corporation won't make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
