**ATTACHMENT TO ARTICLES OF INCORPORATION CA GENERAL COOPERATIVE**

**Fifth Plane Cooperative, Inc.  
(the “Cooperative Corporation”)**

**Limitation of Liability:** The liability of the directors and officers of the Cooperative Corporation for monetary damages shall be eliminated to the fullest extent permitted by applicable law.

**Indemnification:** Subject to any provisions in the Bylaws related to indemnification of directors, officers, employees, or other agents of the Cooperative Corporation, the Cooperative Corporation shall indemnify, to the fullest extent permitted by applicable law, any director, officer, employee, or other agent of the Cooperative Corporation who was or is a party or is threatened to be made a party to any pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that they are or were a director, officer, employee, or other agent of the Cooperative Corporation.
