## Attachment to Articles of Incorporation of a Close Corporation (Form ARTS-CL)

The following subparagraphs shall be added to the above-referenced form:

## "Director Liability

The liability of the directors of this Corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

## **Indemnification of Agents**

This Corporation is authorized to provide indemnification of agents (as defined in Section 317 of the Corporations Code of the State of California) for breach of duty to this Corporation and its shareholders through bylaw provisions or through agreements with the agents, or both, in excess of the indemnification otherwise permitted by Section 317 of the Corporations Code of the State of California, subject to the limits on such excess indemnification set forth in Section 204 of the Corporations Code of the State of California."
