**Additional statements, first paragraph – specific purposes, continued:** The specific purposes of this corporation is to establish a church for the worship of God, spiritual fellowship, and the spiritual growth of its members, as well as to promote the Christian testimony through charitable and educational programs. This corporation shall be empowered to purchase, lease, mortgage, manage, develop, and / or sell real and personal property; receive charitable gifts and contributions; enter into contracts and other business transactions; as necessary for the accomplishment of purposes as stated herein.
