## **Attachment to Articles of Incorporation of Stuttering Treatment and Research Society**

### **SPECIFIC PURPOSE**

The specific purpose of this corporation is to:

- (a) support neuroscience research, especially as it relates to advances in therapy and treatment for stuttering;
- (b) educate others and disseminate information on neuroscience advances in stuttering with the goal of raising awareness and decreasing the stigma of the condition;
- (c) provide therapy and treatment support to persons who stutter; and
- (d) carry on other public and charitable activities associated with these goals as allowed by law.

Such activities are within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law.
