## ATTACHMENT Articles of Organization of a Limited Liability Company

## Marin Foster Care Housing II, LLC

- 6. Additional Provisions to the Articles of Organization:
  - a. <u>Irrevocable Dedication</u>. The properties and assets of this nonprofit limited liability company are irrevocably dedicated to public benefit and/or charitable purposes. No part of the net earnings, properties, or assets of this Company, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any Manager or Officer of this Company.
  - b. <u>Dissolution</u>. On winding down and dissolution, all properties and assets remaining after payment, or provision for payment, of all debts and liabilities of this Company shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its exempt status under Internal Revenue Code §501(c)(3).
