California LLC Operating Agreement

This Operating Agreement is made and entered into on November 15, 2024, by Jose Ramirez, the sole member of Pipeline Masters LLC, a California Limited Liability Company (Pipeline Masters).

ARTICLE I: FORMATION

- 1. Name: The name of the LLC is Pipeline Masters LLC.
- 2. Principal Office: The principal office is located at 406 Staten Avenue Oakland, California 94610.
- 3. Registered Agent: The registered agent for the Company is Jose Ramirez, located at 406 Staten Avenue Oakland, California 94610.
- 4. Formation Date: The LLC was formed on November 15, 2024.

ARTICLE II: PURPOSE

The purpose of the Company is to engage in any lawful business activity permitted in the State of California.

ARTICLE III: MEMBERSHIP

- 1. Sole Member: The sole member of the Company is:
 - Jose Ramirez: 100% Ownership.
- 2. Additional Members: No additional members may be admitted without the written consent of the sole member.

ARTICLE IV: CAPITAL CONTRIBUTIONS

- 1. Initial Contribution: The sole member has contributed \$1,000.00 to the Company as capital.
- 2. Additional Contributions: Additional contributions are not required but may be made at the sole member's discretion.

ARTICLE V: ALLOCATIONS AND DISTRIBUTIONS

- 1. Profits and Losses: All profits and losses shall be allocated to the sole member.
- 2. Distributions: Distributions shall be made to the sole member at times and in amounts determined by the sole member.

ARTICLE VI: MANAGEMENT

1. Management Structure: The LLC will be managed by the sole member, Jose Ramirez.

2. Authority: The sole member shall have full authority to make all decisions on behalf of the Company.

ARTICLE VII: DISSOLUTION

The Company shall be dissolved upon:

- 1. The sole member's written decision to dissolve the Company.
- 2. The occurrence of any event requiring dissolution under California law.

ARTICLE VIII: AMENDMENTS

This Agreement may be amended only by a written agreement signed by the sole member.

ARTICLE IX: MISCELLANEOUS

- 1. Governing Law: This Agreement shall be governed by the laws of the State of California.
- 2. Entire Agreement: This document contains the entire agreement of the sole member regarding the Company.
