Notwithstanding any of the above statements of purpose and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purpose of this corporation.

Attachment to Articles of Incorporation of Orange Firefighters Foundation

SPECIFIC PURPOSE

The specific purpose of this corporation is to:

- (a) Advance and support the health, safety, and welfare of City of Orange firefighters, first responders, emergency medical service providers, and their families;
- (b) Support the education and training of first responders, especially those who serve the City of Orange;
- (c) Support outreach programs that educate and train proactive community members in preparation for emergencies;
 - (d) Provide further emergency support to the greater Orange community; and
- (e) Carry on other charitable and educational activities associated with these goals as allowed by law.

Such activities are within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law.
