### For Valley Flight School, LLC

This Attachment is incorporated into and made part of the Articles of Organization for Valley Flight School, LLC, a California limited liability company, pursuant to the California Revised Uniform Limited Liability Company Act (Cal. Corp. Code §17701.01 et seq.).

#### Article I: Limited Liability Protection

The liability of the Member of this limited liability company (LLC) is limited to the fullest extent permitted under California law. The debts, obligations, and liabilities of the LLC, whether arising in contract, tort, or otherwise, shall solely be those of the LLC. The Member, as well as managers and officers of the LLC, shall not be personally liable for any such debts, obligations, or liabilities.

#### Article II: Indemnification

To the maximum extent permitted by California law, the LLC shall indemnify and hold harmless the Member, as well as any managers and officers of the LLC, from and against any and all claims, damages, liabilities, costs, losses and expenses (including attorneys' fees, judgments, fines, and amounts paid in settlement) incurred or suffered in connection with the LLC's operations or the performance of their duties, provided that such acts were performed in good faith and in a manner reasonably believed to be in or not opposed to the best interests of the Company.

## Article III: Authority to Bind the LLC

Pursuant to California Corporations Code Section 17703.01, no person other than the Member or designated managers of the LLC is authorized to bind the LLC to contracts or obligations, unless such authority is expressly granted by the Member in writing or as set forth in the LLC's Operating Agreement. Third parties are hereby put on notice of this restriction.

#### **Article IV: Additional Provisions**

This LLC is a Single-Member LLC. The Member's spouse, Kay Park-Kim, may act as an alternate signer for specific purposes, if agreed in writing by the Member.

#### Article V: Governing Law

The provisions of this Attachment shall be governed by, and construed in accordance with, the laws of the State of California.
