Specific Purpose, Continued:

The specific purposes for which this corporation is organized are:

1. To promote charitable purposes, by expanding access and exposure to sports and music for low-income youth, thereby combating juvenile delinquency and improving social and emotional health.
 - a. providing them with opportunities to learn and practice sports and music on a sliding-scale basis.
 - b. providing them with financial support to be able to attend and be inspired by professional sporting and musical events.
2. To promote educational purposes by:
 - a. providing instruction in how to play musical instruments;
 - b. teaching classes on topics including but not limited to music history, music theory, and music culture;
 - c. providing instruction, clinics, and workshops to help develop skills in different sports, including but not limited to golf, skiing, tennis, volleyball, basketball, football, skating, and surfing;
 - d. providing training for music instructors and sports coaches;
 - e. providing venues where individuals and groups can practice sports and music, create music, hold musical performances, and have mind-body connection workshops;
 - f. advancing personal development by fostering team-building, enjoyment, and cultural appreciation through structured programs in sports and music.
3. To engage in any lawful activity in furtherance of the above purposes, but in no event will the corporation engage in any activity prohibited to corporations exempt from federal taxation under Section 501(c) 3 of the Internal Revenue Code.

PERSONAL LIABILITY

The liability of directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

INDEMNIFICATION

The Corporation shall have the power to indemnify any agent of the corporation to the fullest extent permissible under California law.
